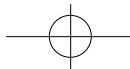
Snarling Dogs^a Limited Warranty

D'Andrea Inc. shall not be liable for any personal injury, property damage, or any incidental or consequential damages of any kind resulting from defects, malfunctions misuse, improper installation or operation, incorrect voltage, or alteration of the Product.

This warranty does not apply to failure of the Product due to misuse, abuse, accident, neglect, mishandling, improper repair, repair attempted by anyone other than an authorized service agent, operation under any conditions other than those recommended or at voltages other than the voltage indicated on the unit, or wear from ordinary use.
